

- Top 5 viable extensions and/or upgrades to existing Schemes (Year 2 2023-24)
- Advise and support top 3 schemes from Year 2 (2023-24) development by:
 - Reviewing top 5 New Systems Strategic Outline Business Cases (SOBC's) and
 - Critiquing 3 Outline Business Cases via UKTram Centre of Excellence

- Help define viability for the top 3 (Year 3 2024-25) Tram Tracker New Light Rail Schemes and
- Top 5 viable extensions and/or upgrades to existing Schemes (Year 3 2024-25)



General Support

UKTram will continue to provide support to Members, Stakeholders, and the industry, by providing advice, sharing Best Practice, Benchmarking, Peer Review, tackling Hot topics and any assistance. Including the ongoing impact and recovery from the Covid-19 crisis. UKTram will continue to collate lessons learnt and share these accordingly.

UKTram and its members will continue to support its subsidiary company the Light Rail Safety and Standards Board (LRSSB) through collaboration, resource, standards, guidance, and document reviews.

The main day to day support and deliverables that UKTram focuses on for Members and the industry will continue through our daily activities the functional groups.

Throughout the uncertain and changing times caused by Covid-19, UKTram will remain flexible and agile to ensure it supports the priorities of its Members and the industry, whilst continuing to strive in improving the Light Rail Sector and maximising the opportunities that present themselves over the next 3 years.

Functional Group Deliverables 2022/23

UKTram's Functional Groups will continue to work on the 'Hot Topic' areas relevant to their Group as required throughout the year. Prioritising the needs of the sector and assisting in data and information gathering to feed into the wider UKTram Work Streams.

The Operators Group (LROC), Engineers Group (LREG), Owners and Authorities Group (OAG), Heritage Tramways Committee (HTC) will be led by the Chairs of each group and assisted in their deliverables by the UKTram team, with Sub-groups like the HR, Communications Group feeding into the main Functional Groups.

The UKTram Centre of Excellence will focus on the main elements of ensuring the industry expertise is dedicated to all the key topics in delivering the Light Rail Strategy and supporting the Government and the Department for Transport in maximising the development and opportunity of Light Rail expansion in the UK across all Light Rail modes from VLR, Tram, LRT, Tram-Train up to Metro level systems.

Summary

Over the next 3 years, as well as the continued daily support and assistance to our Members and the industry, UKTram is targeting some key areas as detailed in the sections above, these are highlighted in a snapshot below:

- Review 15 new Light Rail schemes and 15 proposed extensions for viability
- Support the top 9 viable schemes in implementation
- Support and assist Industry reaching 110%
 Pre-pandemic Patronage
- Support the LRSSB and the continued improvements of safety in the industry, by supporting innovative projects such as FOCUS+
- Through cross mode collaboration assist in achieving an 8% modal shift
- Identify our Industries Carbon Footprint and reduce this by at least 6%
- Increase the sectors career pathways by at least 30%
- Help the sector improve diversity and inclusion by achieving at least a 10% improvement across the industry
- Aid and support up to 15 new, Innovation Grant applications
- Support and aid the implementation of a VLR Pilot scheme
- Trial newly developed Power Technologies that could aid the sector

As a Member's organisation, we aim to be as dynamic, agile, and responsive to changes and new challenges in the industry, so will review and prioritise our deliverables with all our stakeholders.
